

## **Hilton Dining Asia Pacific Membership for AmBank Credit Card /AmBank Islamic Credit Card-i Cardholders ("The Program")**

### **Terms and conditions**

The terms and conditions herein ("Terms and Conditions") are in addition to and are to be read together with the AmBank (M) Berhad ("AmBank") and AmBank Islamic Berhad ("AmBank Islamic Bank") (collectively referred to as the "Bank") relevant credit card and card-i ("Card") agreement(s) ("Card Agreement") which governs the use of the Card released by the Bank . In the event of any discrepancy or inconsistency between these terms and conditions and the Card Agreement, the Terms and Conditions shall prevail in so far as it relates to the Program

### **Definitions**

Except where the context otherwise requires, or unless this terms and conditions otherwise provide, all words, names and expressions defined in the Card Agreement when used or referred to in this terms and conditions shall have the same meaning as that provided in the Card Agreement

- 1) This Program shall be offered for subscription to all AmBank / AmBank Islamic Platinum, Principal and Supplementary Cardholder whose Card account is in good standing and regularised (not in default or not cancelled for whatever reason). Each Cardholder is entitled to one Hilton Membership per subscription.
- 2) To enroll in this Program, Cardholder can sign up at <https://hiltondiningapac.com/ambank>. Within seven (7) days once AmBank have reviewed and approved the membership application. Hilton will then proceed to email the Welcome Email and Cardholder can download the membership mobile app in their chosen provider (iOS – App Store, Android – Google Play).
- 3) To be entitled to the benefits offered under the Program, each Cardholder who has successfully enrolled in the Program are required to spend a minimum of RM30, 000 cumulative retail purchases (excluding Balance Transfer, Cash advance and Quick Cash transactions) over a period of one (1) year from the date of successful membership enrolment. In the event the Cardholder do not meet the aforementioned requirement, the Cardholder hereby agrees and expressly consents for the Bank to charge a membership fee of RM 350 to the Cardholder's Card account
- 4) For the avoidance of doubt each Principal & Supplementary Cardholder's spending shall not be combined and shall be treated distinctly for the calculation of the minimum required amount of RM 30,000 per year.
- 5) In the event of the cancellation/termination of the Hilton membership before the minimum spending requirement of RM 30,000 is met, the Cardholder hereby agrees for the Bank to charge a membership fee of RM 350 into the Cardholder's Card account immediately succeeding the cancellation/termination.
- 6) Membership of the Program will be automatically renewed annually unless the Cardholder decided to terminate its membership by contacting our 24-hour Call Centre at +603 2178 8888, six (6) months before the annual membership expiry date.
- 7) The Bank may disclose the Cardholder's information only to third parties appointed by the Bank for the purpose of banking operations that provide for this service and Program. Upon participation in and acceptance of the Program, the Cardholder is giving consent to such disclosure.

- 8) The Bank & Hilton Dining Asia Pacific reserves the right to approve or reject any application for enrollment of membership at its absolute discretion. The Cardholder hereby expressly agrees to relieve the Bank from any liability, claims or demands regarding the services/ products /benefits/ rendered under the Program which is provided and managed by Hilton Dining Asia Pacific.
