For security reasons, you will be prompted to unlock your phone to proceed on the fourth (4th) transaction.</p> <p>Contactless Transactions without PIN verification are capped at Ringgit Malaysia Two Hundred Fifty (RM250) per transaction. You will be required to perform PIN verification for contactless transactions above Ringgit Malaysia Two Hundred and Fifty (RM250).</p>	<p><b><u>Clause 4</u></b></p> <p><b>4. Variation of Terms and Conditions</b></p> <p>We will provide to you:</p> <p>(a) notice of at least 21 calendar days before we:</p> <ul style="list-style-type: none"> <li>i. introduce or increase fees relating to the use of your Eligible Card with Google Pay;</li> <li>ii. increase your liability for losses relating to transactions conducted using your Eligible Card with Google Pay; or</li> <li>iii. impose, remove or change a daily or other periodic transaction limit applying to the use of your Eligible Card with Google Pay, except where an immediate change is necessary to restore or maintain security or to prevent systemic or individual criminal activity or fraud; or</li> </ul> <p>(b) prior notice of other changes or variation to these Terms and Conditions through email or message notification our online banking system.</p>	<p><b><u>Clause 15</u></b></p> <p><b>15. Variation of Terms and Conditions</b></p> <p>We will notify you:</p> <p>(a) at least twenty-one (21) calendar days in advance before:</p> <ul style="list-style-type: none"> <li>i. introducing or increasing any fees related to the use of your Eligible Card with Google Pay;</li> <li>ii. increasing your liability for any losses related to transactions conducted or made using your Eligible Card with Google Pay; or</li> </ul> <p><b>Clause (iii) has been removed.</b></p> <p>(b) in advance of any other change or variation to these Terms and Conditions via email or message notification service in our online banking system.</p>

Just like contactless/payWave transactions made using physical Credit Cards/-i, there is a RM250 limit per transaction. For transaction above RM250, you will be prompted to key-in the card PIN on the payment terminal.</p> <p>The transaction limit for Google Pay contactless/payWave transactions and online payments is dictated by the transaction limits you have set for your card with AmBank/ AmBank Islamic. Transaction limit for Google Pay is only subject to the credit limit of the Credit Card/-i.</p>	<p><b><u>Question and Answer No. 19</u></b></p> <p><b>Payment</b></p> <p>19.
